STORAGE RECOMMENDATIONS

Store in a cool, dry atmosphere not to exceed 45° F. Shelf life may be extended if stored below 0° F. All products must be stored under proper warehousing conditions and temperatures to preserve the product and prevent discoloration.

EXPECTED SHELF-LIFE

12 months when stored properly.

ALLERGEN STATEMENT

Traina Mediterranean sun dried tomatoes do not contain any allergens as defined by the FDA. These products do contain sulfur dioxide which is used as a processing aid and as a preservative. Some people may be sensitive to sulfites.
