

Dried Apples

DESCRIPTION

Dried apples are prepared from sound, properly ripened fruit which has been washed, peeled and cored, sorted, trimmed, cut to the desired size and properly dried. The product is inspected throughout the process to assure a clean, wholesome product which is in complete compliance with the provisions of the Federal Food, Drug and Cosmetic Act.

INGREDIENT STATEMENT

Apples, Sodium Sulfite added for color retention and as a preservative.

PACKAGING & LABELING

Packed in a non-sealed poly bag inside a corrugated box.

KOSHER STATUS

STORAGE RECOMMENDATIONS

Store in a cool, dry atmosphere not to exceed 45° F. Shelf life may be extended if stored below 0° F. All products must be stored under proper warehousing conditions and temperatures to preserve the product and prevent discoloration.

EXPECTED SHELF-LIFE

12 months when stored properly.

ALLERGEN STATEMENT

Traina dried apples do not contain any allergens as defined by the FDA. These products do contain sodium sulfite which is used as a processing aid and as a preservative. Some people may be sensitive to sulfites.

SDS

These products are a food ingredient manufactured in compliance with FDA and other regulations. They do not contain any hazardous substances and therefore do not require a Safety Data Sheet.
